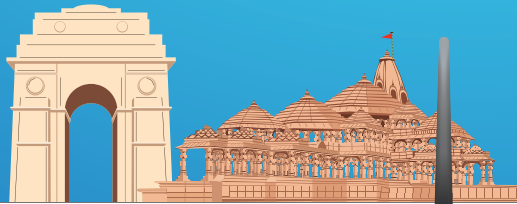

In pursuance of the Hon'ble Prime Minister's vision to fulfil the common man's aspirations of flying and the grand success of the previous edition, the Ministry of Civil Aviation (MoCA), Government of India, Airport Authority of India (AAI) and Federation of Indian Chambers of Commerce and Industry (FICCI) are organizing the next edition of 'WINGS INDIA 2026', a flagship event on the Civil Aviation sector in this part of the world. The event is scheduled from 28th to 31st January 2026, at Begumpet Airport, Hyderabad, India.

## GROWTH DRIVERS OF INDIAN CIVIL AVIATION

- ✈ India is one of the fastest growing aviation markets and currently, the third largest domestic civil aviation market in terms of passenger traffic in the world.
- ✈ Under Regional Connectivity (RCS) - Ude Desh ka Aam Nagrik (UDAN) Scheme, 631 routes and 91 aerodromes have been operationalised till 1st January 2025.
- ✈ RCS-UDAN has facilitated the travel of over 148 lakh passengers since the inception of the scheme, demonstrating its success in enhancing access to air travel for the common public.
- ✈ There has been significant augmentation in India's existing aircraft fleet and the airline operators are operating more than 800 planes.
- ✈ The number of airports has more than doubled in the last 10 years.
- ✈ New Greenfield airports such as Jewar, Noida and Navi Mumbai will add huge capacity to major destinations.
- ✈ India's MRO industry is expected to grow to \$4 billion by 2030.
- ✈ With Foreign Direct Investment being 100% in MRO sector through the automatic route, it is expected that India will be an MRO hub in the coming years.
- ✈ India's progressive drone policies are supporting women's economic empowerment especially in rural areas.
- ✈ Government initiatives like DigiYatra — a biometric-based check-in system at airports — have become the preferred choice for seamless air travel, completing 3.6 crore successful journeys as of November 2024.
- ✈ Over 15% of Indian pilots are women which is more than double the global average of 5% with an aim to reach 25% by 2025, showcasing India's commitment to gender equality.

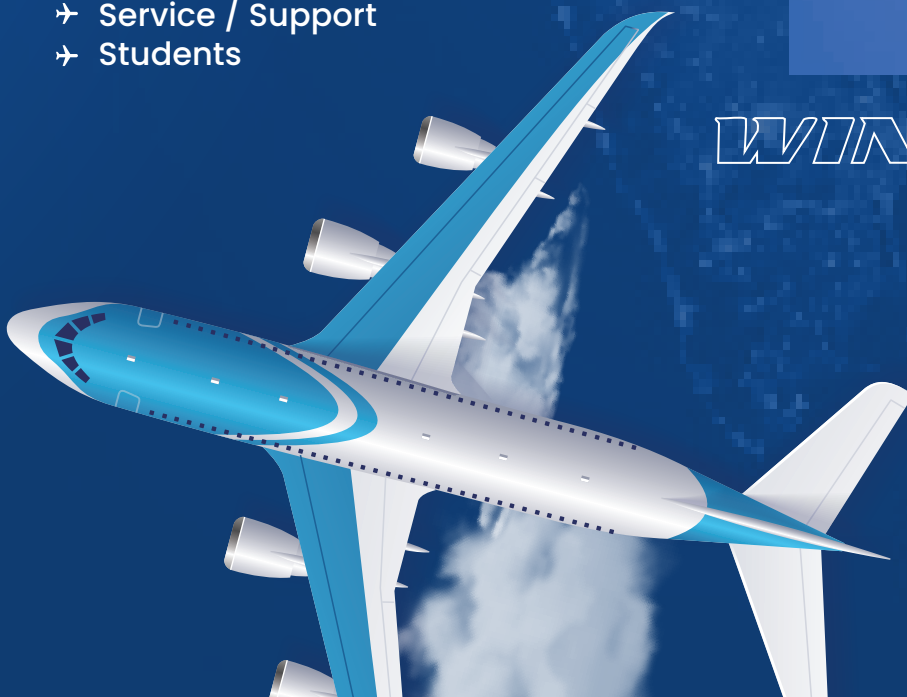

Airports Authority of India (AAI) was constituted by an Act of Parliament and came into being on 1st April 1995 by merging erstwhile National Airports Authority and International Airports Authority of India. The merger brought into existence a single Organization entrusted with the responsibility of creating, upgrading, maintaining and managing civil aviation infrastructure both on the ground and air space in the country.
